Fishing Line is Harmful to Wildlife

The phone at Discovery Park lit up, on average, four times a day during the months of May and June. The calls were all the same, "I was walking around Discovery Pond and there is a goose that is all tangled up in fishing line."

It is so hard to watch wildlife suffer, but it is comforting to know that there are so many good people who want to help. Unfortunately, the Muscatine County Conservation Staff were aware of the tangled goose and attempted several times to capture it without success.

The biggest problem was that the goose could still fly. This made it impossible to catch. The more attempts that were made, the more wary and educated the geese became, making it very difficult. Each time we got too close they would head toward safety, hissing and trying to scare us off.

There is a short period of time in late June when the adults molt their primary feathers and are unable to fly. Staff were trying to be patient and wait for the molt, but we were also afraid that the goose would lose his leg before we could help it.

Each year the Iowa DNR Wildlife Units capture and band a quota of geese. "This year's quota is 150 geese," said Andy Robbins, Iowa DNR Wildlife Biologist at the Odessa Unit. He and his crew were called upon to help capture the geese at Discovery Park so that the goose tangled in fishing line could get the help it needed. As an added bonus, they banded all the geese that didn't already have one.

Muscatine County Conservation is lucky to have a Naturalist with a rehabilitation background. Luke

Hart is excellent at assessing injured wildlife and getting them to a qualified person who can help. He did a fantastic job removing the fishing line and checking this goose for injuries.

The entangled goose still had warmth and blood flow to the foot. The goose lost its hallux, or back toe, due to the fishing line cutting off circulation. This toe is used for scratching or perching but isn't very important for swimming or walking. The goose can still walk with a little bit of a limp, but staff are thankful that the foot was able to be saved, and infection had not set in.

PLEASE, pick up after yourselves when fishing, hiking, or out exploring. Fishing line and other trash are extremely dangerous to fish and wildlife. They can become tangled, or accidentally eat it, thinking it is food. Please use trash receptacles or carry your trash home with you.

The Environmental Learning Center even has a box in the entry way for anglers to deposit used fishing line for recycling.

Thank you to everyone who took the time to help or call about the injured goose. It is nice to see so many people caring about Discovery Park and its many inhabitants.

Park Spotlight: Saulsbury Bridge Recreation Area

Saulsbury is a 675-acre, multi-use recreation area located approximately 8-miles NW of Muscatine at 2007 Saulsbury Road. With the Cedar River making up most of the western border of the park, ecosystems consist of a mix of floodplain forest, open fields, creeks, and wetlands. This unique mix provides a diversity of wildlife habitats and outdoor recreation opportunities.

A total of 601-acres are dedicated to wildlife habitat and are open for public hunting. The area is popular for species such as deer, turkey, squirrel, and rabbit.

The remaining 74-acres are utilized for recreation. This part of the property contains two boat landings. One for accessing the Cedar River and one on Chicken Creek with a fishing dock.

The Saulsbury Lodge is a great location for medium-sized gatherings such as family reunions; youth, scout or church groups; small weddings; graduation, or birthday parties.

There are three campgrounds at Saulsbury including the Main Campground with 24 sites including 20-30-50 amp service. There is also a shower house, potable water, dump station, playground, and firewood shed. Sites are reservable online at MyCountyParks.Com.

The River Campground and Tent Only Campground do not have electricity, but there is a latrine nearby and guests are welcome to utilize the facilities in the main campground.

The Saulsbury Bridge sits just behind the Lodge and looks out

over the Cedar River. It no longer crosses the river, but offers a great lookout view or picnic spot.

Horseback riding is allowed on many of the trails at Saulsbury. There is a grassy parking area specifically for horse trailer parking.

The area is also open to all sorts of outdoor enthusiasts include hikers, birders, paddlers, photographers, and those who simply enjoy a walk in nature.

Saulsbury is also the location for several school field trips, School of the Wild, and the annual Halloween Drive Through.

Sadly, we lost one of our long-time educational owls this summer. Thurston II was a great-horned owl who sparked awe and curiosity in so many who met him. If you ever walked by to visit his mew or saw him on a glove at a program, undoubtedly you remember a majestic bird with bright yellow eyes and large black and brown ear tufts. Thurston was a quiet owl, giving only the occasional light hiss when disturbed. According to former Naturalist, Dave Bakke, he only hooted once on a traveling program. Perhaps at night, though, when no one was around to hear, Thurston sang out to the park. Thurston came to Muscatine County Conservation Board (MCCB) in 1993, after injuring his wing past the point of repair. He lived 32 years at both

Saulsbury Bridge Rec Area and Discovery Park, teaching the public of the importance of predators and the wild places they rely upon for survival. On a warm Tuesday evening in August, Thurston passed away. We don't know exactly how many lives Thurston has touched. We do know, however, that we will remember him for a very long time. Farewell, friend...and thank you.
